

INTRO 2 - CSA

MENTALITY OF CULT MEMBERS

The following Flowcharts One, Two and Three portray this concept:

- Flowchart 1 depicts the strategic defence system of cult members which by way of design, pitches victim against victim. This is considered the artform of ultimate alibi.
- Flowchart 2 drops down cult mechanism and mentality. Isle one depicts mechanism and device, isle two depicts simplistic overview of cultivation and deployment of Cult Scout, and isle three depicts Cult Master's control over Cult Scout.
- Flowchart 3 simplifies a rather lucid example of Cult Master fetish, Cult Master Objective, and the Scouts who become Cult Masters in their own right. Outwardly, the latter is displayed by public servants who I have often noticed, confuse their status of social worker (e.g.), with that of presiding judge, outside the courtroom.

Annexed hereto and marked "C" are these 3 flowcharts referred to.

MASTERS AND THEIR SLAVES:

1. There is a foul gradient of sadistic realism that steepens with the knowledge that this secular cult has firm roots in both ancient and modern times..., in both local and international waters.
2. Please forgive the potentially offensive use of euphemism and metaphor in following three paragraphs, necessary to accurately portray 'motive and mentality'.
3. A theme of Master and Slave. A church of sanctimonious sadism. A game of dungeons and dragons. The laying of traps to 'catch a nigga (or some other poor innocent 'b**tard') by the

toe' – until slave bends to will of Master. Their global playing field mapped by Indigenous lands taken over by foreign forces. Public uniformity, professionalism and alliance obscures the secret rapture of predators scheming in disguise, exacting forms of sexual perversion marked by love of cruelty, and a love of inflicting pain, on only the most vulnerable among us – our babies and children.

4.The height of self gratifying ejaculation climaxes when the pre–uplift victim is dragged kicking and screaming to the altar of sacrifice – the premises of Child Youth and Family, and the homes of CYF Approved Caregivers where pre–uplift Masonic abuse is surreptitiously erased, and evidence of abuse is diverted to parent. Many of these cult member judges 'get off' on hearing the wounded expressions of parents.

5.The nature of cult control is best illustrated by visualizing the imagery of a beehive. When king or queen bee gives an order, whether right or wrong, the worker bee's comply – without question, and sometimes..., without knowledge that they carry out the orders of murderers, thieves, and sadist abusers, totally unaware that they inflict pain in loyalty to Cult, due to trust in an allied member's ethics.

CULT PRACTICE

6.Cult practice is wrought with sadism – the violating of innocence through terrorist tactics known only to clan and click, but now by the publicising of this affidavit, to the general public of Maori, New Zealand and Global Society. I believe this cult stems from the hiding of incest, the torturing of the same, the fostering of paligamy, and the hiding of other crimes.

7.Public uniformity, professionalism and alliance obscures the secret rapture of predators scheming in disguise, exacting forms of sexual perversion marked by love of cruelty, and a love of inflicting pain, on only the most vulnerable among us – our babies and children.

CULT MEMBERS BEST KEPT SECRETS

Common methods used to 'condition a victim' is intimidation, threat, summons and bribe, which when actioned over a period of time, becomes a gauntlet of fear and entrapment. Place the frog in the pot, heat slowly until boiling temperature, and the frog doesn't know it has been cooked, not even by the time it is dead.

8. Chop off a part of the dogs tail, and the dog whimpers in pain. Chop off another piece, and the dog cries again. By the time the dogs tail is half missing, the dog doesn't want the tail anymore – such reveals what I believe is one of the main tactic's used by Child Youth and Family, and Chief Executive Of Ministry Of Social Development – and their supporting Ministries, in particular, Ministry Of Education. This is how they train children to betray beloved parents – through fear of abuse. This is common cliché of cult mentality.

CULT MEMBER MOTIVES

9. People want things that belong to others all the time. Usually it is your wealth, your beauty, your health, or your youth – the latter being one of the biggest motives of all – the effervescent seek of the fountain of youth. In other cases, it is the cost of being born into the wrong family – or country. Yet in many cases of CSA behaviour, it is the cost of being born inferior. Often, brown skin is perceived by cult members as 'inferior'. And yes, in the right portrait, particularly from hindsight..., this is seen by those proud of their heritage, as the folly of the proud. They bypass the true and gentle meanings in life, and miss out on life's true meaning. To be virtuous but fiercely defensive of your good morals, is to stop yourself from becoming a cult member my children, and I know you all know this. I know too, that in the face of real battle, all this 'lovey-dovey' language goes right out the window, and the only real meaning, is deactivating an enemy by any means possible – stopping them from harming you. The reality is, given how often we have all had to sustain murder attempts, death is often the only possible outcome. It's either them, or us. We must win.

10. After all..., we are dealing here with the same mentality that nailed Jesus Christ to the cross, while multitudes felt helpless to do one dam single thing. It is the same mentality that saw American Soldiers sexually pervert Iraquian soldiers, and the same mentality where blacks were not allowed to sit in the same restaurants and churches as white people. It is the same mentality that saw mutitudes of Jews forced into Nazi Concentration Camps and gassed in

secret torture chambers. Just because the war ended, didn't mean that the attitudes did. Though to the credit of all humanity, we have come a very, very long way thanks to the loving leadership of the global greats like Bob Marley, Nelson Mendella, Rodney King, Abraham Lincoln, Jesus Christ, and the main man – Michael Moore himself..

A WALK DOWN MEMORIAL LANE

11. In the 1950's, here on Aotearoa soil in an area close to Sebastian Point(?) in Toa Tu Ia aka Tamaki Makaurau aka Auckland City, a village settlement of Maori people were burned alive in their villiage huts and Marae, because they refused to give up their Maori Way of Life to live in the purpose build state houses for them (us) to convert to foreign dictatorship. Their blood curdling screams could be heard from Princess Wharf./The Quay. It was worse for the Jew families gassed by the hundreds and thousands. On a windy day, fires were lit on the Whangaparaoa Peninsula, burning all the Maori settlements to make way for the immigration of foreigners who wanted this prime piece of real estate for themselves – and their beloved children.

12. And on a final footnote of this haenous treatment of Maori people, Maori children were 'beaten' in English speaking schools when they spoke their native language – Te Reo Maori. Welsh speaking people were treated the same, as were Aboriginie, and many other proud indigenous cultures taken over by foreign forces. This is the psychological backdrop that sets the stage for many of the policies, laws and legislation that now govern Maori – by force. This is not right. It is not even moral. Maori have perfectly good powers of judgement and reasoning that will see all our tribes united in loving embrace over our lost loved ones, our lost culture, and our lost civilisation. Contrary to the shared beliefs of both Maori and Pakeha, Maori were not so much at war as our 'victors' would have us all believe. We were essentially a peace loving people in tune with nature. Inter-tribal wars pre-european invasion, were undoubtedly apparent, but nothing like it became when the European Invasion depopulated Maori with guns, and stole our lands, bribing some, denying others. We have all suffered, we have all been enslaved. We all feel the loss of our land and loved ones. We are all the hero's in this secret war against us.

13. Logical deduction, powers of discernment, sum of experiences, and a keen pursuit of truth, leads me to conclude that CSA is a bonafide system of secret abuse exacted by people who

abuse their positions of authority for reasons of personal grudge, gain, and prejudice. And in contradiction of the above... – don't we all when we think that no one is looking. But I try not to, and I know my children have tried their best not to as well.

HISTORY OF CSA:

14. I believe in days gone by, certain members of New Zealand Government contracted the services of foreigners from abroad, and neighbouring countries to infiltrate and incriminate Indigenous peoples to justify their taking over of our land and prove to the rest of the world that we were nothing but savages – an untrue statement.

15. Maori were and remain very much a peace loving people until we were thrust into chaos by foreign forces that laid entrapments so vile and secreted, we were rendered powerless to adapt and knelt in mercy when our children were taken from us. We love our children. We love our land. We share an affinity with nature that graces our understanding of astral travel and 'navigation by stars'. Many Maori agree, that as Indigenous, we reserve the right to educate our children according to our unique set of cultural beliefs established long before the migration of Pakeha to our shores. And so shall we continue to defend our right to live in freedom and moral righteousness.

16. The reality is, unless it is in genuine self defense, anyone who believes they have a right to pay, post, bribe and deploy a course of action designed to harm another human being, is a member of cult whether they be Maori or Pakeha, child or adult.

17. It is my belief, that CSA first originated from the early days where prisoners of war were tortured in enemy camps. This terrorist behaviour bled into our Maori societal systems and thus, when the Indigenous fell victim to foreign control, imprisonment under Mental Health Act and Jails, became the socially accepted venue to continue this secret agenda – without detection – or question. Sadly, such abomination to Maori Society still continues today, and with this affidavit, I hope, pray and trust that we will all bring a final end to its long and uninhibited history, for the love of our children – our self love, and our very souls. Over 70% of people under the New Zealand Mental Health Act are Maori.

18. Today, I believe certain descendants from cult member people still carry out this agenda in secret, and in public by way of electoral vote, with barely a sideways glance, inadvertently willing these war-time tragedies forward momentum. I assert the fact that there is a surviving and accelerating trend of government agenda behind CSA that behind pious quip and quote of moral righteousness, belies a very dominant movement of secrecy.

19. In these modern times, knowing from personal experience that there is a New Zealand judge in the family court participating in CSA, I must therefore assert that the overall concept of CSA (Contracts Of Secret Abuse where a 'special secret reserve treatment of punishment' is actioned in tandem with legal and community privileges bestowed by government), is to artificially impose entrapments that force good men, women and children to commit crimes of self defense in life threatening situations, which becomes 'one such' judges alibi for delivering those he chooses, to a sentence of imprisonment. Meanwhile, their wealth in their absence is dissolved by legal legislation – yet another motive for the imprisonment and punishment of people, as opposed to their rehabilitation, the latter being the only prerogative of Maori justice, particularly when appraised of the fact that Maori are generally not given the reigns to write laws that protect themselves and their cultural advancement, as evident by the current political landscape of this country. In this country, and likely the next, appearances are not often what they seem.

CSA – CONTRACTS OF SECRET ABUSE (“CSA”)

20. When understanding my full disclosure of CSA, the entire scale of these secret agendas of abuse shall be referred to as 'CONTRACTS OF SECRET ABUSE' aka CSA.

21. The participants and drivers of CSA shall be referred to as 'cult members'. Cult members, particularly in reference to main heading **INTRO 2**, but also in a fundamental sense, shall be referred to as PPP and SS. PPP means Primary Predatory Perpetrators. SS means Secondary Switchers. **Refer annexion “A” (as detailed in KEY), for a full list of new definitions and meanings that shall be referred to throughout this affidavit.**

22. The behaviour of CSA cult members shall be referred to as ‘cult influence’.

23.As a whole, the people involved in CSA are to be recognized as a **SECRET SOCIETY**, knowing from experience that they exist in absolutely every walk of life, and are renowned for exacting their abuses in secret – usually at night, in the code of cult member secrecy. **Please refer Flowchart 1 referred to at beginning of main heading INTRO 2.** It will be useful for flow of acquired perspective to look at this now. Flowchart one depicts defense system of CSA, being the reason these injustices have continued unchecked for so long.

24.The main Contract's Of Secret Abuse that this affidavit refers to is Child Sale Abuse aka **CSI(1)**, however in this section of this affidavit, I will expose CSA in it's broad context of the meaning, rather than it's specific forms of CSA.

25.Briefly however, the specific form of CSA(1) abuse that this case seeks to expose, magnify (in the very best sense of the meaning), and deal with, is detailed under main heading **INTRO 1.** Forthwith, I provide an indepth explanation of CSA in general terms.

26.For some of my readers, this may be a labyrinth of information to digest, but such, is the nature of this case, so try to keep up with the twists and turns that my children and I have had no choice but to, in our fight for our lives, as the main targets of CSA, for what I discover are very historic reasons.

27.And by hook or by crook, all PPP and SS will try to pull the wool over our eyes, and have us believe that my children have not been impregnated as kids themselves, yet a New Zealand Media article, proves this as fact. My child involved, was Charlize–Beautiful. This is her name. She can tell you, what she named her child. I know that it's either Misty Blue or Honey. But no doubt, by now, her child's name, has been confused with her cousins.

BROAD CONTEXT OF CSA

28.CSA is representative of various forms of 'cult' behaviour. In it's most fundamental dictionary meaning (Collin's paperback) the word 'cult' is defined quite harmless. But develop your own sense of psychic intuition, or ESP as you prefer..., or throw yourself into this investigation, and

you will see for yourself, that the word cult in 'real terms', has a very dangerous meaning.

29. So deadly in fact, that many of these children are beaten up very badly, stabbed with knives, beaten and raped so hard, their skin breaks. I have witnessed this on my own beloved and most gentle child, and through my own first hand experience with my siblings, I know first hand, how this feels like non other than a living state of murder.

30. People who actively participate in CSA, whether they be directly or indirectly involved, are rolling this blood red carpet of child abuse downhill with the strokes of their pens that belie the secrecy of their swift and callous punches to children's young and vulnerable bodies. They are usually people who have been 'abused' as children themselves, and repeat the moral debt of their childhood abusers. Or, in the theme of this case, many do it for money. Such is recognized as the social stymie of this case. The death trap for children who are not believed when they are being abused by those vested with their care, when they report the truthful facts of this testimony, due to the seemingly impenetrable defense system of PPP and SS.

31. When these abused children become adults, unless they (like my daughter's and sons), have remained in tune with their 'inner child' – and in mine and my daughter's case – their child age pregnancies..., yes, believe it, it's true..., I am deeply angered to say..., that they will not see the wisdom in changing until someone intervenes in their secret regime of sexual deviance, and, as is often the case – experimentation on human beings. And I've got more proof than you can shake a broomstick at pun intended. Heni, my Katariina. I am so in-love with you. Thank you for loving me. And f**k those people who take that heartfelt message in an immoral way.

32. Before I had seen so many wounds on my children, and displacement of their body parts..., and the artificial conjunction of other peoples body parts..., I had not believed in capital punishment. But now that I know..., I am as keen to torture and torment these people, as they have been in tormenting and torturing my own. And that goes double for those of you in the police force, in Child Youth and Family, and in community who are acting honest, when you are anything but. Yes, these abuses are tantamount to a declaration of war. But no, I will not stoop to such unrest. Instead, I will forward this case to a New Zealand Court. If it is rejected, I will raise funds, and take it to a worldwide court. If that does not work, then, as I do so now..., I

will stand on the Maori Declaration Of Independence 2008, which reinforces MDOI 1977, as founded by my father and I.

33.As deeply as I regret to inform, knowing the truly insane and unforgiveable harms that have been caused to my children and I..., many PPP are victims of CSA, and have been artificially 'tailored' by those who would have us believe they are sane, when they unconscionable.

THE DAMAGE THAT ONE PPP CAN CAUSE, IS MASS DESTRUCTION

34.The damage that one PPP can cause is enough to mislead majorities about exactly who is responsible. On the other hand, one cunning PPP or a like-minded SS, can cause an entire country to co-operate with their bullying behaviour when sitting in the right seat of power. And as referred to in the diagrams referenced in Intro 2, all it takes, is one robust defense system.

35.In this sense, CSA, as are many of CSA's mental health labels designated by their commercialized forms of religion – aka government..., right along with the people who invented these contracts of secret abuse..., are totally artificial. What we are looking at here, is an entire judicial system based on the Code and Conduct of the Masonic Brother-hood, who use their strategic influences, with little manifestation of moral boundaries. So you could say, that I'm a 007. An under-cover M.O.A. Police Warden, just as motivated, and where circumstances warrant, just as deadly, when poised in the protection of my children. Be so advised. I will kill to protect them. They have sacrificed their very lives to protect me, and help me reveal CSA1.

36.I believe, that in days gone by..., New Zealand Government was founded by pirates and people who escaped war crimes during Germany's marriage with England. I believe it to be England and Germany's best kept secret. But for all we know..., we are talking here about the Free Masons alone. Or a religious click of bretheren. Or even, one corrupt judge skilled in the devices of CSA bribe. Thus, I share with you a few weapons of the CSA(1) trade.

CSA WEAPONS

37.I illustrate this for you with the following example. You can meet a stranger one day, and

befriend them. They will eat meals with you, and sip cups of tea to the tune of skillful conversation. All the while, they are weighing up your vulnerabilities, sizing you up for strength, counting the heads in your family, accounting your wealth, and planning the entry to your home in the still of the night. And before you know it, both you and your child have been anaesthetised, drugged, raped, and abused. And by morning, you will be none the wiser. Not even your beloved child may know the causes of their violated private parts. "You will see rape scars, you will be too afraid to report this to police". "You will forget". "You will respond only to masters control". "You will do as I say". "Shut your mouth". These and more, are the familiar phrases that are whispered to you while you gulliver in your sleep.

38.This has been the reality for many of my children and I, who have had our authentic memories replaced with false ones, and predominately, are 'fine tuned' to forget. And by children, I mean all who have sacrificed their lives, to help me uncover the secret abuses of secret abusers.

39.Narcotic's, hypnosis, anaesthetisation, severe abuse while anaesthetised, fertility drugs, pigmentation injections, a common drug known as "G" found in the liquid of CD cleaner, threat to loved ones, accessing of private information, explorative surgery and murder, employment of evidence cleaners, changing and switching of identities, holding pens, abuses of the most severe kind, and now you know what my children and I have been battling our entire lives.

40.And by my children and I..., I mean all victims of CSA, including my most greatest alliances – the children of incest like me, who have had a guts full of this crap (pardon me your honour), and have decided to take action, and deliver our enemies a final message they will never forget. Their days, are numbered. Our quest for justice now begins with this final and completed affidavit. New Zealand Mental Health – your unconscionable rule of our minds no longer has power over us. Gangs who control minds through recreational abuses..., your power over my children and I is diminishing. You will not pass GO. You will not collect \$200. The monies you have collected for stabbing and abducting my children, will be returned, unless, for some reason, you decided to be good, decent and kind to them, and treat them with aroha, liebe, love. My eternal and deep respects to those of you, who have helped my children. I am at your service. Ask of me what you will, and where I am able, it shall be done.

41.We will deactivate you with equivalent forces where necessary, as the honourable braves of

M.O.A. Police Wardens. Steve, all members of local and international community..., and all you very kind and loving people of Maori, NZ, and international community..., thank you. From the bottom of our hearts.

SELF DEFENSE

42.Those who deploy equivalent forces in genuine self defense like my children and I, like all members of our family who have been victimised by the bullies in our own families, have done our absolute best to stop harm without harm or cause the least amount of harm necessary. To doubt this, is to doubt the often fragile and gentle nature of my children. And when that fails, 'kill' the attacking perpetrator.....

43.These are the very character traits by which my children and I are to be recognized as the real hero's of this case. We have sacrificed our very lives to expose this deadly 'game' of Child Sale Abuse, and in some cases, it would appear that our most precious children have been murdered. I am therefore calling on New Zealand Government to take urgent action. If you won't – I will. This is the most serious statement of justice I will ever make.

44.I now briefly discuss, what may seem to many who read this, as a well hidden form of racial genocide. Where Maori were predominantly the targets, today, everyones children and teenagers are at risk of Child Sale Abuse. As for exactly who is at risk? Anyone with a matching blood type. And you need only read todays front page of the New Zealand Herald dated Tuesday, 21st February to know that this case, has some very wide parameters.

Source: Health Quality & Safety Commission. You believe these results? They only scratch the surface of the real casualties. Now imagine, if this has been the fate of any one of your loved ones? I've met people who tell me this happened to loved ones in their own family. Two are European. Do you know what they answer to me when I ask them what they did to correct the injustice? "There's no point, they are too well fortified" – words to that effect.

53.I've even heard that someone blamed the earlier version of my website www.globalmaori.info as their reasons for their rape and/or murder of one of my children. And IF that is true, now you know the extent of racism in this country. A prime example of how PPP commit crimes, and blame their victims, because "they can't substantiate their hate, so they make up their cover, and they violate".

CSA – CHILD SALE ABUSE aka CSI(1)

54.Food for thought. Isn't it such a telling sign that 'bastard' is one of the most common swear words of the English language. Perhaps this fact depicts an era where bastard children were hunted and killed by their own parents, and worse yet, and entire government? And what of the Mental Health Patients who get away with murder because New Zealand Mental Health deems them 'non-responsibles'? But of course! Clearly it is still going on today.

55.“Child Sale Abuse” abbreviated as CSI1, is therefore one of the definitive forms of CSA that this case seeks to expose, deal with, and deactivate – for good. It is the deadliest form of child abuse this world will ever know. It is without a doubt being exacted by professional criminals and families allied by the raping and molesting of their own children, and the destroying of their results of incest – now the gold mine of explorative surgery, and internal organ replacement, in exchange for cold hard cash.

56.The rape, murder and torture, of the most innocent and gentle spirited children, some as young as newborn, who literally beg for death when forced to submit to insane dismemberments,

and cruel emotional and mental tortures (like telling my children that I don't love them, or that I am dead..., or forcing them to wear someone else's body parts while their own internal organs and limbs are stolen for the use of CSA cult members hellbent on ritual), and the facts of this case reveal terrors that absolutely none of us would wish on our worst enemies.

57. A noble statement, given the toll of abuse that has cost my children their lives with me. A convenient perspective when not engaged in battle. A perspective maintained during the heat of battle, by nobility of children unfamiliar with the meaning of hate, when a child is pitched against the blinded rage of an adult threatened by the existence of a child that 'carry's the rapist's DNA. You feeling me now Judge L De Jong? I know what you did to my children and I. And you will pay back all the money you have accepted for every single one of my stolen children. You hear me Judge? Blackmail you say? Is that what I hear echoing from the private chambers of your courtroom while you rape my child like a sadistic vampire hungering for child flesh? Poppy cocks you say? I couldn't have put it better myself – in the literal sense of course.

58. By the way, was it you who put Tahi and Carol up to injecting my children with illnesses? Sickle cell disease? Is that what you got Harvey and Grame to inject me with before the court case on 9th August 2011? Surprised to see me alive were you? Yeah, your murder attempt failed. Ha-ha! Merry Christmas you say? Well Happy New Year – back!!! Guess what else? I have photo's of all my children, and videos of my children that your lap dogs have been holding hostage at Barnardo's, raping, pillaging, and molesting. Aren't you so wonderful. Clearly devoted to the sadistic violation of the most innocent human beings. My my.

59. Back to my readers. Worse yet – is the criminal quest for eternal youth – the desire to always look and appear younger – sexier – more attractive. It is true, that I suspect that one of the main ingredients in Botox, is made from the unique qualities of fetus and/or embryo cells. Therefore, the mass production of these cells are required by pharmaceutical companies keen to make sales. Not sure what this technology is called, but I am certain, that aging people, physically ill people, and those people hell-bent on maintaining their youthful looks, are the main buyers and recipients of Child Sale Abuse – akin to cult members secret society of alliances – of course, who abduct adults whose body parts match their own need for replacements.

60. Or in the case of my beloved child – a heart replacement – two of my children now have pace

makers. I am witness to the woman who has transferred most of my toddlers blood into her body, stolen her heart, and is now looking 25 at around age 40, who locked my daughter in her garage, by chain and padlock. And the 60 year old man running around Orewa college, who I believe has one of my children's hearts in his body, is now running like a 30 year old.

THE CORRUPTING OF OUR YOUNGER GENERATIONS:

61. I believe there is a growing cult of people in both older and younger generations, who take sadistic pleasure from other peoples pain as many of my children have discovered. One had her bottom enlarged by the staggered insertion of rings, the other was forced into her bottom. No doubt, their identities were disguised. My daughter who felt impact, begged for death. No doubt they did not show this when the video was shown on www.youtube.com, but if you have a copy of this, turn off the volume and read their lips. Need I say more? This is what people do to children at parties, and in the homes of CSA cult members. These are the types of experiences that cause many people (but not my children), to become cult members themselves. I believe my two daughter's from one of my set of triplets were 'melted together' this way, by use of a concentration of radiation. They are the ones who now require 24 hour medical attention. I trust by now, that to prove me wrong, cult members have restored them to their normal individual selves. God don't let them die..., I beg you.

62. There appears to be a large following of people in this country who find 'art' in obscuring and violating innocence. Evidence of this can be found in the two pictures I have seen from two different local families, where children have been shown with wounds on their face, and one facing a corner of a room wearing a gas mask. I refer to these children as 'child pets' as they are usually detained in private homes for 'various uses' including blood and internal organ replacements, and . I find these pictures very disturbing. I am unsure whether I am allowed to upload them onto www.globalmaori.info due to copyright laws. I suspect these pictures may have been created with real children. Children who were landed (by entrapment), in the bidding quests of 'people in power', who enjoy abusing the children of people they hate.

63. Not only do I find this so-called 'art' disturbing, but I find it hard to even fathom this concept. Other than what I have written here, I will attempt to understand this concept no further. The

very thought fills me with a heart ache known only by a parent who has had to bear witness to their child being raped, murdered and harmed, while I watch helplessly through my psychic perception, and can all but communicate advice to my children. From the perspective of parent..., this is the most severe pain on earth. To know that your child suffers, while you have your hands cabled behind your back and can do nothing about it. I therefore seek some swift law changes, not to mention, some immediate arrests. So I have made a decision. Even if it means going against the law NZ Law, I am going to do whatever it takes to save my children from these abuses that may now see some of them crippled in their minds for life – but not if I've got anything to do with it. Believing in my ability to heal my children of these ails remains my only hope. The healing of the Maori Tohunga therefore remains my obligation and commitment.

64. Believing that my love-based healing and my faith in the unseen and moral spiritual forces that be, will heal my children from whatever ails them, remains my most fervent and sincerest belief. Believing that Jesus and my Maori Tohunga father (recognized his innate spiritual blueprint for moral righteousness) helps me to heal my children. Whether a person is declared a criminal or not, I believe in the philosophy that people are born good – without crime, which is a fact derived from my study of watching children grow, develop, and rejoice in their gift of life when love-based parenting is the strength of a family's unity.

65. Absolutely every single one of my children thrived in my loving and kind care of them, when they didn't have to hide due to threat of death, abduction or rape. It is not mums fault that so many people attacked us my girls and boys..., it is the fault of a secret society of war mongers hellbent on destroying Maori people for their land, land profits, and highly esteemed culture. Whether foreigners like to admit to this truth or not, I feel the truth of this statement within my own management of my life, and my children's management of their lives in my absence. We are to be credited for our brave ascent into this darkness of chaos, debilitating fear, and threat to our life forces.

66. My very own children have been 'set up' by criminals to perform criminal activities, and have been abused in jails – both locally, and internationally. Now how does a parent even begin to deal with a stymie of this magnitude? Some parents give up, as do their children. This is why,

New Zealand Government has one of the highest rates of suicide in the world. And more often than not..., deliberate murder is made to look like suicide, once again, implicating New Zealand Government's highest statistics in the world. You can see a video of me under my Family Album link on the homepage, that appears as though I was hung either before or after being drugged. You can see this in the way my skin on my neck appears. One of my daughter's, was hung by a Judge L De Jong's daughter Kathryn Harvey who contract's to Child Youth and Family in Orewa. If I am not mistaken, my very 'presence' of healing bought my daughter back to life. At Barnardo's in Whangarei, one of my children who could not walk, was healed. I believe my Maori Tohunga father also has significant involvement in my children's healing. He died 30 years ago. My children, my grandchildren, and my great grandchildren know him as Papa Tahi. They communicate with him, and he with with them, often. As aforementioned, it is not uncommon for me and my children to be seen speaking to people who are not physically present. On that note – no, I have never been under the New Zealand Mental Health Act – on record. Off record, I believe my children and I have sustained the most severe forms of abuse by New Zealand Mental Health cult members of CSA.

67. Long story short, New Zealand Government – or should I say – those government leaders involved, have been killing Maori behind closed doors because no listens to Maori in this country. I can confidently state that this is government agenda, based on the deliberate structures of previously government owned houses and courtrooms that speak ugly abuses behind closed doors. Namely, the doors of NZ Parliament, and an entire floor inaccessible to the public. I have often seen smoke rising out the top of the Auckland District Court rooms. Nazi agenda did not end with America's findings of their crimes. It merely moved behind closed doors and became New Zealand Government's best kept secret. The statistic's speak volumes. Once again, this is real, it is happening, and many children in and outside of prison can testify to this reality of New Zealand Government Abuse by their very own design.

68. To defend yourself when it comes to adults hurting you, whether that be by killing them if they won't stop, or running away from the abuse – your most honourable preference I know..., then this, makes you a very, very good girls and boys, and of this you can be most proud. Proud like the Indian Brave. Proud like the Maori Warrior. Proud like the Samurai. Proud because you know you did so to protect – not to harm. And you make sure the judge knows this for all

you are worth, and do not accept anything less than a firm reliance upon your own strength of character!!!

BESTIALITY AND THE USE OF SEX AS A WEAPON BY CULT MEMBERS:

69. I feel most vehemently about asserting the truth behind bestiality in this beautiful country of Aotearoa, among its equally beautiful people. Through human beings' natural destiny to be inquisitive of life and all its intricate complexities, scientific study has taken on very seriously questionable parameters. Scientific exploration evolved into the study and experimentation of secret forms of warfare, the study of sexual behavior of animals evolved into bestiality, and experimentation with human(s) evolved into the testing of marketable drugs for profit. Bestiality? All thanks to cult member scientists who study the reproductive behaviour of animals, who integrated this perversion into their seynonce rituals – being but one explanation. Being naturally inquisitive, is yet another. Being so inclined, is largely unnatural for all people, so once again, bestiality is to be recognized as an artificial outcome. A man-made abomination to human society.

70. I myself, know that I would commit bestiality in a heart-beat, if that is what it took to share the emotional burden of my children being violated and perverted by cult members. And I suspect that in addition to a few people in the Hibiscus Coast area who have sex with animals (but feign innocence in public), that some who have captured or bought my children, are subjecting my children to forms of bestiality, including, making their animals attack my children, by training their dogs with the smell of my children's clothing. I can always tell who these people are, because their dogs growl at me. What they do, is they steal my undies, and my children's clothing articles, and teach the dog to bark and attack those who bear the scent. This is done to ensure that if I come to save my children, the dogs will go berserk and attack me and my children, and alert the hostage holder, to ready his rifle, and shoot to kill, like many cult member Police officers do. And that my friends, is the unadulterated fact of this case.

71. The adulterated fact of this case, is 'sex'. Sex when 'seen', becomes a powerful force. Only those who know this information and are so inclined to 'fight to remain moral and decent', are able to consciously deactivate these addictive urges with the right remedies. In the case of my

children and I, speaking openly about sexual experiences forced upon them is one of the pivot points of healing, and the journey toward rehabilitation. Alas, for others, sex is but a stepping stone to achieving a climax of violence and violation. Aye Tahi. You teaching you son to do the same are you? Little Tahi will never be like you, even if he has already been abusing my children like you have taught him to. Little Tahi, you speak the truth about your father when the police come. If you don't, there are many eye witnesses, that will prove that you saw things that you should have told the police about, but didn't. So behave young man, or Aunty Nellie will be very upset with you.

72.Many pedophiles created by this torturous experience in childhood may lose the ability to make good choices for themselves when abuses are over-whelming (thank you Edward). This is by no means any excuse for crime. It is merely an element in the equation of cult driven mentality – to drive a person to suicide by invisible forces. This therefore, is the reason so many people, even those who commit crime, are victims. Again, this is no excuse, and they – we, must all be held to account. Given my experience of my children's pain, and my failure to protect all my children from these unconscionable inhumanities, I have written my early findings of the pedophiles mentality.

Annexed hereto and marked “D” is my recently written report on the pedophiles mentality. These concepts were foreign to me until 2011, 2012. My only regret, is that I woke up to these facts – much too late.

FURTHER TO THE TABOO TOPIC OF BEASTIALITY

73.I have never ever been inclined toward bestiality, and stand firmly against it. Such abomination to society goes against the grain of everything I have learned about the affinity of Maori with nature.

74.I myself, while having admitted to childlike acts of bestiality at three intervals in my childhood, believe this to be the acts of Mental Health experts adept at manipulating mind control through drug influence and hypnosis, OR, the obvious motive of cult members trying to drive Maori into a corner of psychological suicide. Additionally, I believe this may have been a result of slip

streaming.

75.As a psychic tracker or investigator, this is how I sometimes track people – by becoming aware of their spiritual signatures propelled by intensity of feeling – often by visualisation. FYI, I am not psychic about everything, only that which is impressed upon me at the time. My psychic perception, as with my children's, works to a timing and rhythm destined by the powers that be. The seer cannot force it, and it cannot be manipulated by force. Only true and moral love makes this possible. So if you have ever met my children, and they have spoken of visions and communication with people unseen, then if you have crushed their spirits, I guarantee, you will be held accountable in a Maori Court of Law – of that I assure you.

76.That said, if any of my children have been subjected to this unforgivable monstrosity, I would want to have the same done to me, so that I know how it feels, and can share in the remedy and solution knowing how best to heal them from such a terrifying experience. Such is my love and loyalty to my children. If they have been raped 1000 times, I would wish this same death upon those who inflicted this pain. I want only healing and rehabilitation for these children. This would be the only reason I would allow myself to be victimised by these terrorist crimes. In the great words of Jung, only those who experience, are best qualified to analyse remedy and create healing solutions. Naturally, ethics must shape this philosophy – not the mad principles of sadists.

77.But on the other hand, I would want a revenge so monumental, that it shakes the very foundations of capitalism in this country, which I believe to be the catalyst of CSA1.

GIVE MAORI A FAIR GO

78.Where Maori have been 'labeled, criticized and blamed as having the highest rate of child abuse in the world..., I most forthrightly assert that it is usually the ones accusing that are carriers of the guilt.

79.Such abomination to Maori society first arrived when Nazi and Masonic Cult arrived. To doubt this fact in any way, shape or form, is to continue this great injustice to Maori.

80. Given the history of human torture and abuse by NZ Mental Health, and all public servants who are cult members, I can all but feel duty to expose these human tragedies.

81. In an effort to discredit my political agenda, I have been the victim of some very creative abuses by those who fervently wish to keep this secret cult fetish and CSA agenda hidden. Video's falsified by use of narcotic's and hypnosis have been deliberately made to discredit me, and my fight for my many, many children. I suggest, they have a whole library of similarly made video's about many people, and especially the children of these people. I believe that some of them, have even been published by NZ Herald. Not 100% certain at this stage, as I was drugged when I believe I saw the article in August 2011, which co-incided with Ministry Of Social Development's case against me. I believe that this is the reason why – because I exposed a lot of this information on www.globalmaori.info.

82. So my wager to the public is this. If you want to believe that I am guilty of the crimes of criminals, that is your choice. If you want to believe that I am guilty of the crimes committed in protection of my young, then do me the same honour, that you do for other police officers who actually don't deserve it in some cases. The fact of the matter is, some police officers are good, and some police officers are affiliated cult members perpetuation this cycle of abuse. The same can be said of judges, doctors, social workers, environmentalists, scientists, and you name it, they, have their finger in every pie, including the most famous of charities.

83. One of the most significant of cult abuses, is forcing sex changes on children, and then exploiting them in front of their police officer and cult member colleagues. Imagine the pain of waking up with body parts that do not belong to you. But not to be mistaken, is the fact that many non-officials also do this to children. Some gang members rip babies out of woman's wombs to hide DNA evidence. Some of the people who do this, attend your local gym. They hold "as I now believe", after hours sessions where they rip, rape and raw children. I have seen psychic perception of this, hence the reason I believe it to be fact. And doubt me if you will, but my conviction is unwavering. And should an evidence to the contrary be made know, then naturally, in the interests of fair pursuit of the truth, I keep an open mind, but not, in respect of

cult members manipulation of evidence.

SEXUAL DEVIANCE OF CSA CULT MEMBERS:

84. Sexual orgies present the most powerful and addictive urge/drug of all known human fallacies. The acquisition of wealth is its next of kin. It takes a very knowledgeable and knowing mind to overcome this abominable urge. The bad news is that sadly, many succumb and pass on this moral debt to their children. The good news is that thankfully, a good many of us don't, and pass on our learned life skills to our young. Such is my parenting style. It always has been and I will most righteously and vehemently challenge anyone who dares to say otherwise. As absolutely every single one of my children can testify to, along with all my nieces and nephews – if they are being totally honest with themselves and with me.

85. However, by recognizing the truth of this affidavit too late, I recognize how I have failed them all in the most unforgivable of ways. Their heart break and ruin, is therefore mine to own and bear. I should have done more, I could have done more, but I was just too damn frightened to break the law. But place me in a situation where my beloved children need protecting, and my strength of Samson knows no bounds. I have already proven that I can tip over a vehicle to stop it from taking my babies as once happened in Glenelg street in RedBeach. I once tipped over a van of electrical appliances to stop it from taking one of my daughters from me. Fact. Other women have been known to do this too.

MOTIVES OF CSA

It's all about the putea. It's all about the money.

86. Generally speaking, cult influence is in my astute and knowing opinion, a reflection of a 'sex culture'. It was spawned from the days where sex orgies were the accepted norm of early civilisations and the delight of those victorious in the days of war. I suspect that many cultures, civilisations and hierachy's were built upon this dangerous flaw of humanity. The days of the

concubine and the many mistresses granted to the kings of empires is evidence of this culture, but not necessarily the extension of these immoral boundaries for which experimentation of human beings and animals took firm foothold in these secret societies of abuse.

87. Jealousy, prejudice, want of 'more', and hate are the two main motives for CSA. These are two very natural human emotions that even I feel tendency toward from time to time, as naturally as children do. As an example of how open-minded I am going to ask my reader to be, I ask the reader to ground themselves with this concept – *“even to regard one's self as 'holier or more deserving than another'... is to be found guilty of 'discriminatory hate” and 'cult member affiliation'.* There are of course exceptions to every rule, but certain, there is no room for compromise in my books.

88. In my experience, along with my knowledge of information I have gleaned as a part of informal case studies, psychic instinct and vision, and my logical powers of deduction, I perceive that the main motives for CSA are status domination – the asserting of superiority complex over perceived inferiority, the hiding of polygamy, and the hiding of incest (which becomes very powerful motives for abuse, murder, and hate – especially the hate that results when one gets 'found out' – caught red handed, or 'snapped out' as I like to put it), I have attempted to illustrate the secret movement of cult influence.

EVIDENCE OF CULT:

89. The greatest evidence of this cult, (with regard to the cult members motivated by wealth acquisition), lies in the fact that many NZ citizens remain unmoving in their deeply coveted confiscation of Maori Land and our children. For me at least, no analogy illustrates this unhealthy mentality of cult better than the character and words of Sméagol “my precious”. I trust this character needs no title credit.

90. I offer my sincere and humble apologies for my blunt revelations, however, given the sum of mine and more—so my daughters and son's sufferings, I fear I have developed something of a cynical retainment of facts. After reading this affidavit, I hope my readers of all nationalities may

find in agreement, or at least, a level of empathy.

91. One of the crowning victories of cult members is to photograph and video tape evidence of their victims suffering. The greater the suffering, the greater the glory. I believe, that in this area, there is a strong following of cult members. They secretly go around forcing innocent people into compromising positions, and then photograph and video tape them through use of narcotics, hypnosis and threats of violence to loved ones.

In my case, I suspect videos were made by those who have attempted to steal my bonus bonds, to damage my credibility in the eyes of the international community. I believe that ultimately..., none other than Mental Health is responsible. And if this is true, you can be absolutely certain, that I am not the only victim of this type of abuse. You yourself may have a video or photographs sitting in the head offices of CSA.

IN HONOUR OF THOSE WHO STAND AGAINST CSA:

92. **In 1977, my father Tahi Wiri Matene and his wife Ulm Ivy Morton, were instrumental in both the exposure of human torture and testing by New Zealand Mental Health, and the release of many Mental Health hostages, which resulted in the 'shutting down' of a couple of New Zealand Mental Health institutions, including Carrington Hospital, Kingseat, and one other institution (Alice/Ellis ?) that I have been advised of today by a Court Balif. My beloved mother Ulm was forced against her will to become a 'patient'**

93. For this reason, I write this affidavit in honour of these people, but equally and moreso, my children who have suffered unconscionable abuses – along with three European NZ Police Officers and their families, who lost their lives trying to help me investigate the pre-uplift abuse of my daughter by cult members. I am also deeply concerned about the pizza guy who I believe also lost his life. I only know this through psychic ability, and will be speaking to this boy's father in due course.

LAWS THAT PROTECT AGAINST CSA:

94. In regards to my children, NZ law states, as per Children, Young Persons and their Families Act 1989 Section 6 Part 1; Welfare and Interests of Child or Young Person Paramount. Please refer my Opening Speech and Cover Letter which exemplifies this point. **Annexed hereto and marked "E" is my Opening Speech and Cover Letter.**

WHO IS AT RISK?

Anyone with a matching blood type.

95. I reiterate. Absolutely everyone is at risk, from layman to leader, simply by being in the wrong place, at the wrong time – especially children who are naturally inquisitive. Often life saving organs are needed as a matter of timing more than anything else.

96. My children and I who suffer stress reactive memory loss (drug induced in all cases I now believe), people with impediments whose testimony is not likely to be given due credibility in court, people suffering ailments and people who for legitimate reasons, believe in the spiritual talent of psychic ability akin to ESP or De Ja Vu who are vulnerable to being labelled as delusional. Refer pages 28–39 of boldly marked 'supplied' file "D".

97. As an adult, you may never know at which point in your own life, that you may have been subjected as a child or as an adult, to this type of CSA abuse. Even your own grown child may be a victim as most victims have their minds manipulated to forget, and often won't recall specific abuses and trauma without some form of conscious examination. There are many factors to this equation, however, I trust I have provided the reader with a well rounded explanation of the broad context of CSA.
